The collective agreement between Management and Trade union committee of students and Student council of NTUU "KPI" [the draft]

The conference of labor collective of the University in accordance with the applicable legislation, including compliance with the Law of Ukraine "On Collective Contracts and Agreements", "On Higher Education", "On Trade Unions, their Rights and Guarantees" Labor Code of Ukraine, General and Sector agreements and other, instructs a trade union of primary trade union organization of students of NTUU "KPI" and student council NTUU "KPI" to conclude a collective agreement between the Administration of KPI and students, graduate students. **(further - students).**

1. General Issues

Obligation of administration are:

1.1. Recognize priority right of Trade union students, Student Council of NTUU "KPI", Student council of campus NTUU "KPI", SSA of NTUU "KPI" to participate in the preparation of collective agreements in accordance with the applicable legislation.

1.2. Give opportunity for trade union students and student government of the University to include their representatives to scholarship committees and commissions, which are considered (settled) students and graduate students issues.

(Rector)

1.3. The planning and allocation of funds of University departments that directly affect the interests of students, conduct involving trade union representatives of the students and the student government.

(Rector, vice-rectors, head of DEF)

1.4. In agreement with the trade union committee of students of NTUU "KPI", Student Council of NTUU "KPI" and student council of campus NTUU "KPI" (as of):

- establish the internal regulations of the University, internal regulations in student hostels, the schedule of the educational process;
- encourage students and graduate students for success in educational, scientific, sporting, cultural and social work;
- provide financial assistance;
- issue orders expulsion of students and graduate students from the University for a single gross violation of discipline or internal regulations, for committing an immoral act which is inconsistent with the continuation of studies in the student group;
- issue orders, provisions relating to the learning environment, housing, welfare, entertainment and recreation students.

(Rector, vice-rectors, deans of faculties, directors of institutes)

- ▶ Staying of Director of the BSUN Permanent International Secretariat at NTUU "KPI"
- ▶ The win of basketball players
- ▶ Meeting with first-year students

1.5. The University provides for trade union students committee of NTUU "KPI" campus of Student council of NTUU "KPI" and student radio NTUU "KPI" an opportunity free space with necessary equipment, lighting, heating, maintenance for their work.

Administration provides for trade union students of NTUU " KPI", campus of Student council NTUU "KPI" and student radio NTUU "KPI" the possibility of free communications in the city, transportation, copying technology to disseminate timely information among university students.

(Rector, vice-chancellors, directorof campus, heads of departments)

1.6. According to industry agreements for the personal statements of union members, to conduct cashless payment of membership fees and transfer them within 3 days after payment of grants to the account of trade union students.

(Head of DEF)

1.7. Promote trade union committee of students, student government and trade union staff in monitoring the work of catering facilities at the University and the results of audits to take effective action.

(Rector, director of TSSH, deans of faculties, directors of institutes)

1.8. To support the activities of the student government and the trade union committee of students.

(The first Vice-Rector, vice-rectors, deans of faculties, directors of institutes)

1.9. Together with the trade union committee of students and the student government at the University, to promote the donation according to the Law of Ukraine "On the donation of blood and blood components."

1.10. Provide trade union of students, the Student Council and the Student concil of campus of NTUU "KPI"

reasonable response to their request, information on decisions concerning students admitted commissions and councils, under the current legislation.

(Rector of the NDP / NVR, deans of faculties, directors of institutes)

The trade union committee of students NTUU "KPI" and Student Council of NTUU "KPI" undertake:

1.11. Work together on areas of activity in activities planned by collective agreement, to inform students about the implementation of the Collective Agreement.

(The heads of the trade union committee of students of NTUU "KPI", Student Council of NTUU "KPI" and head of Trade Union Bureau and student councils of faculties (institutes))

1.12. Together with the administration to develop an action plan for carrying out educational work among students to:

- respect for property, classroom, laboratory fund assets campus;
- improve educational and social discipline;
- savings of heat and electricity;
- improving the sanitary condition and fire safety in buildings, hostels and the territory of NTUU "KPI".

(Head of the trade union committee of students of NTUU "KPI", Student Council of NTUU "KPI", campus of Student Council of NTUU "KPI" and head of Trade Union Bureau and student councils of faculties (institutes) hostels)

1.13. To participate in the distribution and management of funds allocated for the welfare needs of students of cultural, educational, sports and recreation activities, implement measures to further involvement.

(Head of the trade union committee of students of NTUU "KPI", Head of the Student Council NTUU "KPI" campus Student Council of NTUU "KPI")

1.14. Participate in the discussion and development of the University regulations relating to students.

(Head of the trade union committee of students and head of the Student Council "KPI")

1.15. Consider at its meetings the issue (presentation) made by the Administration of the University and provide an excerpt from the minutes of the time, according to the address specified period but not later than seven days after treatment.

(Head of the trade union committee of students of NTUU "KPI", Student Council of NTUU "KPI", campus of Student Council NTUU "KPI" and head of Trade Union Bureau and student councils of faculties (institutes) hostels)

2. Social security and providing scholarships

Obligation of administration are:

2.1. Money of scholarship fund use according to the Order of use of funds provided for the payment of scholarships and financial aid awards to students of NTUU "KPI".

(The first Vice-Rector, Head of DEF)

2.2. In the cases of involve students in activities, not related to the implementation of the curriculum, agreements on data of conduct involving trade union committee of students of NTUU "KPI", Student Council of NTUU "KPI" and the Student Council of campus of NTUU "KPI" compliance with appropriate conditions work, living and recreation to the previous mode definition / scope of work and salary / remuneration.

(The first Vice Rector, Rector of the NDP / NVR, deans of faculties, directors of institutes)

2.3. In forming the schedule to adhere to the rules of workload.

(First Pro-rector, deans of faculties, directors of institutes)

The trade union committee students of NTUU "KPI" and Student Council of NTUU "KPI" undertake:

2.4. To participate in the scholarship committee of the University, faculties and institutes with scholarships, providing financial aid and awarding students.

(Head of the trade union committee of students of NTUU "KPI", Student Council of NTUU "KPI", campus of Student council Of NTUU "KPI" and head of Trade Union Bureau and student councils of faculties (institutes), hostels)

2.5. Provide accounting students who need financial aid, and provide assistance in accordance with the law.

(Head of the trade union committee of students of NTUU "KPI", head of Trade Union Bureau faculties and institutes)

3. Training, researching and innovation activities

Obligation of administration are:

3.1. To ensure proper conditions for training students under Temporary Regulations on the organization of educational process in NTUU "KPI". Promote appropriate learning conditions for students and postgraduates, according to sanitary standards and logistical base.

(Rector, vice-rectors, deans of faculties, directors of institutes)

3.2. Promote the development of research, design and innovation of students as well as the creation and

operation of scientific circles and sections at the University.

(Rector, vice-rectors, deans of faculties, directors of institutes)

3.3. Comprehensive support and organization of scientific and educational activities at the University, including conferences, summer schools, workshops and courses with students of NTUU "KPI".

(Rector, vice-rectors, deans of faculties, directors of institutes)

3.4. Promote and encourage postgraduate students to achieve good results in their studies, participation in research and creative activities.

(Rector, deans of faculties, directors of institutes)

Student Council of NTUU "KPI", Science Association of Students of NTUU "KPI" undertake:

3.5. Together operate within the measures approved by the university rector on education, research and innovation among students.

(Head of the trade union committee of students of NTUU "KPI", Student Council of NTUU "KPI", Student Council of campus of NTUU "KPI", SSA of NTUU "KPI" and head of Trade Union Bureau and student councils of faculties (institutes) hostels)

3.6. Take a steps to popularize science and attract students to scientific research at the University.

(Head of the Student Council of NTUU "KPI", SSA of NTUU "KPI" and heads of departments (institutions))

3.7. To promote the creation council of excellent students to promote the achievement of high performance in educational and scientific work of students.

(Head of the Student Council of NTUU "KPI", SSA of NTUU "KPI" and heads of departments (institutions))

3.8. Carry out work to raise additional funds for the implementation of student research and innovation projects and conduct research and educational activities.

(Head of the Student Council of NTUU "KPI", SSA of NTUU "KPI" and heads of departments (institutions))

4. Improving living conditions

Obligation of administration are:

4.1. In forming the plan of the University for the new school year to ensure the priority of works of repair of vital communications and utilities campus hostels by the relevant departments of the University, student teams and building groups of students. Together with the trade union committee of students of NTUU "KPI", Student Council of campus of NTUU "KPI" and student council form of priority list of objects overhaul campus.

For additional agreements, engage funds units University campus to prepare for the new school year.

(Rector of the NDP / AChRs, deans of faculties, directors of institutes, director of campus)

4.2. Extra-budgetary funds received as rent from business organizations located in the campus (excluding utility costs) and rental of campus infrastructure directed to conduct repair work and development of material base of campus.

(Rector, Director of campus)

4.3. Use campus housing in accordance with the provisions of the settlement and accommodation in hostels campus of NTUU "KPI".

(Rector, Director of campus)

4.4. About changes in execution plans repair work and on budget adjustments of NTUU "KPI" for such work to inform the trade union committee of students and student government.

(Rector of the NDP / AChRs, director of campus)

4.5. All funds received from paying for accommodation in hostels campus, lead to the development of logistics campus.

(Rector, Vice-Chancellor, head of DEF, director of campus)

The trade union committee of students NTUU "KPI", Student Council of NTUU "KPI" undertake:

4.6. Participate in the development and discussion of construction projects, current and capital repair of buildings and hostels in the formation of student groups and teams of repair and landscaping of the University.

(Head of the trade union committee of students of NTUU "KPI", Student Council of NTUU "KPI", Student Council of campus of NTUU "KPI" and head of Trade Union Bureau and student councils of faculties (institutes) hostels)

4.7. Promote the development of catering to the academic buildings and hostels of the University, to control their work.

(Head of the trade union committee of students of NTUU "KPI", Student Council of NTUU "KPI", Student Council of campus of NTUU "KPI" and head of Trade Union Bureau and student councils of faculties (institutes) hostels)

5. Organization of leisure of students, strengthening of resource base of culture and sport.

Obligation of administration are:

5.1. Promote the culture of leisure in students environment.

(Pro-rector, director of campus)

The trade union committee of students NTUU "KPI" and Student Council of NTUU "KPI" undertake:

5.2. Develop and fully support the work of the various forms of leisure of students (student clubs, cafes, discos, creative and artistic groups, hiking clubs, etc.). Promote the development of their material and technical base. Raise additional funds for the repair and maintenance of premises of cultural work at the University.

(Head of the trade union committee of students of NTUU "KPI", Student Council of NTUU "KPI", Student Council of campus of NTUU "KPI" and head of Trade Union Bureau and student councils of faculties (institutes) hostels)

5.3. Ensure distribution of tickets among students of NTUU "KPI" for cultural and sporting events at the University and beyond, received or acquired by the trade union committee of students and Student Council of NTUU "KPI".

(Head of the trade union committee of students of NTUU "KPI", Student Council of NTUU "KPI", Student Council of campus of NTUU "KPI" and head of Trade Union Bureau and student councils of faculties (institutes) hostels)

5.4. Agreed with the Authority of mass cultural, sports and social events held at the University.

(Head of the trade union committee of students of NTUU "KPI", Student Council of NTUU "KPI", Student Council of campus of NTUU "KPI" and head of Trade Union Bureau and student councils of faculties (institutes) hostels)

6. Sports and recreation work of students

Obligation of administration are:

6.1. Promote of sports, sports day in various kind of sports at the University, faculties (institutes) in the campus.

(Rector of the NDP / NVR, deans of faculties, directors of institutes)

6.2 Together with the trade union committee of students NTUU "KPI" and Student Council of NTUU "KPI" organize and rest, treatment and rehabilitation of Students for recreation and rehabilitation University according to the Regulation on the distribution and provision of vouchers for recreation and leisure students of NTUU " KPI ".

(Rector, Vice-Rector of the NDP / AChRs, head of trade union committees of students and staff, the head of the Student Council of NTUU "KPI",health-improvement committee of University)

6.3. Ensure timely financing costs sanatorium-dispensary under its approved budget and keeping the provisions of the sanatorium of NTUU "KPI". Carry out repairs of premises, upgrade medical equipment and equipment Sanatorium-dispensary and attract additional funds for this purpose.

(Rector, Vice-Rector of the NDP / AChRs, Head of DEF)

6.4. Together with the trade union committee of students and staff of NTUU "KPI" and Student Council of NTUU "KPI" develop a plan for reconstruction and development program student mountain-sports camp "Globe" (Ivano-Frankivsk region., Vorokhta village).

(Rector, Vice-Rector of the NDP / AChRs, Head of DEF)

The trade union committee of students NTU "KPI" Student Council "KPI" undertake:

6.5. In accordance with the applicable legislation to take measures for the treatment, rehabilitation and recreation of Students of the University.

(Head of the trade union committee of students NTUU "KPI" and Student Council of NTUU "KPI")

6.6. Together operate in measures approved by the administration and staff of the trade union committee of NTUU "KPI" repair and training camps.

(Head of the Student Council NTUU "KPI" and trade union committee of students and staff NTUU "KPI")

6.7. Conduct informational campaign to attract students to the recreation center of NTUU "KPI" during the season and wellness weekend.

(Head of the trade union committee of students of NTUU "KPI", Student Council of NTUU "KPI", Student Council of campus of NTUU "KPI" and head of Trade Union Bureau and student councils of faculties (institutes) hostels)

6.8. To work to attract additional funds to repair the premises, upgrade equipment and medical equipment health center, recreation and rehabilitation University.
